## WP4: PILOT TESTING OF THE FLEXIBLE AND GENERIC DHEM (Leader: P10-DHBW/DE; Co-Leaders: P13- AWSB/PL)

#### A4.1.1/ Identification and conceptual definition of Dual Study Programs:

- All Project Partners are asked to upload the Study Plans endorsed by the Ministry of Education on TRELLO in the corresponding folder on Drive.

#### A4.1.1/Elaboration and signature of agreements:

- All Project Partners are asked to upload the scanned copies of the Agreements signed with the companies on TRELLO in the corresponding folder on Drive.

#### A4.2./ Development of training materials:

- Separate email with instructions has been sent. Deadline for submission: 15<sup>th</sup> August 2022. Final version of the training materials will be uploaded on TRELLO.

## A4.3./ Purchase of equipment:

- MD: Delay in acquisition of equipment because of the change of raise of prices on the market.



Co-funded by the Erasmus+ Programme of the European Union



- UA: 2 delays: 1<sup>st</sup> delay in registration of the project for TVA exemption; 2<sup>nd</sup> delay in change of price and possibility of delivery of goods.
- UA partners will adopt the final list of equipment due to the changes caused by the War and will send to the Grant Coordinator for approval; The changes will be in quantity of goods already authorized in order to avoid the request for authorization from EACEA.
- Authorization of the equipment list from EACEA is needed ONLY in case new items are added to the previously approved list. In case of increase/decrease of quantity of items, no authorization is needed.
- In July 2022 the adopted list of equipment will be sent to the Ministry of Education for approval. The procurement is planned for September 2022.

# A4.4./ Piloting of Dual Study Programs:

- Each MD and UA Partner has a budget of 5.000 EUR for promotion of the Dual Study programs. The budget must be divided for two academic years. The materials may include any promotional instruments such as spot video, advertisement on radio or TV channels, mass media advertisement, any printing materials.
  - Partners, planning to start the piloting in 2022-2023 academic year have to start the promotional campaign.
- All MD partners start piloting of the DHE Study Programs in September 2022;
- UA partners: Taken into account that in 2021 the regulation of Dual Education was adopted in Ukraine, all COOPERA project partners from Ukraine already know how to implement the DHE models selected. Due to the problems caused by war, some partners from Ukraine will not be able to start piloting of the Dual Study programming in the upcoming academic year 2022-2023.
  - P6-KROK and P8-ONEU plan to start piloting in October 2022.
  - Due to the complete destruction of the university building of P7-KKNU and the Kharkiv city in general as a result of the War, the piloting of the DHE programs will not be possible this academic year.
