Overview of the system of higher education in the Republic of Moldova

**21 higher education institutions:** 

13 public universities, 8 private universities 17 universities concentrated in Chisinau (the capital), 4 regional universities(one in the North, 3 in the South)

- Universities provide level 6, 7, 8 EQF, cycle I, II, III QF-EHEA study programmes (colleges provide level 4, 5 EQF programmes/not part of the higher education system)
- 21 doctoral schools
- **60000 students** (bachelor, master and doctoral programmes)
- Part of EHEA since 2005 (signatory of Bergen Communique)

# Existing fields of study and percentage of students enrolled

The higher education system in the country ensures the preparation of specialists in about 172 specialties.

- •*Education*17,2%
- •*Humanitarian Sciences and Arts* 5,6%
- •Social Sciences, Economy and Law 33,0%
- •*Sciences* 5,9 %
- •Engineering, Processing Technologies, Arhitecture and Constructions 28,2 %
- •*Agriculture* 2,10%
- •*Medicine* 3,2%
- •*Services* 4,8%

Integration of Dual Higher Education in the framework of mid-term and long-term vision of MER

• **Development Strategy "Moldova Europeană",** approved at 23.09.2022

*Strategic Goal 3*: guaranteeing relevant and quality lifelong education and learning for all

*Specific Objective 3.3*: Developing an accessible, flexible and relevant system of continuing trening of adults in the context of lifelong learning

*Specific Objective 3.5*: Modernization of university curricula from the perspective of development of transversal and interdisciplinary skills.

Action 2: Development of dual higher education

Existing legislative framework allowing the development of Dual Higher Education programmes in Moldova

- Art. 100 Internships: Internships shall be organized by higher education institutions and shall be carried aut within institutions, organizations, companies, associations, and other structures, according to the Framework Regulation approved by the MER
- Art. 110 Relationships with the labour market and business world: HEI shall prepare highely qualified staff in partnership and for the labour market by:
  - -organizing continuing professional trening

-organizing trainings and internships

-employment of highely qualified staff provided for by HEI

- Framework Regulation on the organization of internships in higher education (2015)
  - types of internships
  - duration; responsibilities of parties

## • Art. 59 (6) Regulation on the development of dual technical vocational education

- organization of theoretical activity at the institutions and the practical activity at the enterprise
