## Legal framework regarding dual higher education in the Republic of Moldova

- General objective 3. Ensuring the educational system of all levels and forms of education with qualified, competent, motivated and competitive didactic/scientific-didactic and managerial staff;
- Specific Objective 3.5: Modernization of university curricula from the perspective of development of transversal and interdisciplinary skills.
- Action 3.5.2. Elaboration and approval of the Regulation for the organization of initial professional training programs through dual education.

# Education Code of the Republic of Moldova no. 152/2014, amended Law no. 257 of 17.08.2023

#### Article 89. Bachelor's degree – cycle I of higher education

(9) In higher education for bachelor degree, cycle I, dual education can be applied for certain specialties, under the conditions established by the Ministry of Education and Research through coordination with other relevant central bodies and interested economic agents.

### III. Law nr. 110/2022 regarding dual education

Purpose - the regulation of **dual education** as a form of organization of professional technical (vocational) education provided by the Education Code.

Order 1351 of 26.10.2023 - the working group was established for the elaboration of the framework Regulation for the organization of dual higher education at the bachelor's level (cycle I).

- The main objective of the dual higher education system is to contribute to the organization of a training process for future specialists, which will ensure the national economy with highly qualified personnel who possess not only theoretical knowledge, but also practical skills.
  - The Ministry of Education and Research proposes piloting dual higher education in the following specialties/study programs:
- I. Preschool Pedagogy, Pedagogy in Primary Education, Teacher Training (Educational Sciences);
- 2. Applied Informatics (the general field of studies Information and communication technologies);
- 3. Business and administration (Economic Sciences);
- Automation and informatics, Robotics and mechatronics (Engineering and engineering activities)

### V. The Dual Higher Education Concept in the general field of Educational Sciences

The Ministry of Education and Research developed the Dual Higher Education Concept in the general field of Educational Sciences.

It is important that this educational model shall be initiated in the training of teaching staff within the Preschool Pedagogy, Primary Education Pedagogy, Teacher Training programs, by discipline to ensure the educational system with qualified, competent, motivated and competitive teaching and managerial staff.

Placing students in general education institutions will facilitate the development of a wide spectrum of important skills for future pedagogues, favourable conditions will be created for the development of professional skills specific to the field of education.
